We are pleased to announce we will be granting eight academic college scholarships for the school year 2026-2027 to currently graduating Seniors from Tulsa County high schools. The scholarship will be awarded based on academic achievements and community distinction. Each scholarship will be granted in the amount of \$10,000.00 to be awarded in four annual installments of \$2,500.00. The award provides scholarship funds without repayment.

### ELIGIBILITY

To be eligible, the applicant must:

1. Be a dependent child of an active law enforcement officer or firefighter who works in Tulsa County.
2. Attend a two or four year college or university in the United States with plans to complete a bachelor's degree.
3. Complete all three pages of this application and return timely **along with a letter of recommendation, transcript and a list of other scholarships** as specified below.

### ATTACHMENTS/PROCEDURE

Each application must include at least one letter of recommendation from a high school counselor, principal or teacher. In addition, please attach an official copy of the student's high school transcript for the last seven semesters, which must come from the school. Documents stating only GPA are not acceptable. Applications must be received on or before 5:00 P.M. **Wednesday, MARCH 11, 2026** by mail, fax or email.
